

## ACKNOWLEDGEMENT AND UNDERTAKING

I, RESHA JHERMAINE JIMENEZ, hereby acknowledge and undertake as follows:

1. I acknowledge that I am a registered member of the College of Dental Hygienists of Ontario (the "College").
2. I acknowledge that as a result of an investigation there were allegations made that I:
  - a. received assistance from another individual to complete the National Dental Hygiene Certification Board Quality Assurance examination; and/or
  - b. assisted another individual to complete the National Dental Hygiene Certification Board Quality Assurance examination.
3. I acknowledge that those allegations have been referred by the Inquiries, Complaints and Reports Committee (the "ICRC") to the Discipline Committee of the College.
4. In light of these allegations, I have decided to retire and, in the circumstances, I agree that it is in my interest to resolve this matter without a contested public discipline hearing.
5. I undertake to cease practicing and to resign and surrender to the College my certificate of registration with the College on the date on which I sign this Undertaking.
6. I undertake to never apply for membership, registration, or licensure or similar status with the College in any registration class as a dental hygienist or registered dental hygienist;
7. I acknowledge that if I ever apply for membership, registration, licensure or similar status with the College in the future, the College will be entitled to rely upon this undertaking in any registration or other similar proceeding as grounds to deny my application and/or in any prosecution for breach of this undertaking.
8. I acknowledge that the College will be entitled to prosecute me with respect to the specified allegations that were referred by the ICRC and for breach of this undertaking if I ever breach any part of this undertaking, and that such prosecution may proceed (in accordance with section 14 of the *Health Professions Procedural Code*) even though I have resigned my certificate of registration.
9. I acknowledge that the College will seek to indefinitely adjourn the discipline hearing as soon as possible after my resignation has become effective and will only seek to bring the discipline hearing back on if the Registrar believes I have breached this Undertaking, and I hereby consent to this indefinite adjournment.
10. I acknowledge that once my certificate of registration is surrendered, I will not be entitled to use the title "dental hygienist", "registered dental hygienist", or any abbreviation thereof or equivalent in another language, I will not be entitled to hold myself out as a person who is qualified to practise in Ontario as a dental hygienist or registered dental hygienist or in a specialty of dental hygiene, and I will not be entitled to imply that I am a dental hygienist or registered dental hygienist in Ontario.
11. I acknowledge that the College will post the contents of this undertaking on the College's public register which is on the College website.
12. I acknowledge that any breach of this Undertaking may result in allegations of professional misconduct against me being referred to discipline.
13. I acknowledge that I have consulted with legal counsel prior to entering into this Undertaking.
