**ORDER**

**THIS HEARING** was held on July 24, 2018, in Toronto, Ontario.

**ON READING** the Notice of Hearing, the Agreed Statement of Facts and the Joint Submission on Penalty and Costs, and on hearing the submissions of counsel for the College of Dental Hygienists of Ontario ("College"), and the submissions of counsel for Samantha Wehrle.


**A. THE DISCIPLINE COMMITTEE FINDS** that Samantha Wehrle is guilty of professional misconduct pursuant to clause 51(1)(b.1) of the *Health Professions Procedural Code* (the "Code"), being Schedule 2 to the *Regulated Health Professions Act, 1991*, and pursuant to s.51(1)(c) of the *Code*, particularly paragraph 2 (contravening, by act or omission, a standard of practice of the

profession or failing to maintain the standard of practice of the profession.); paragraph 47 (contravening, by act or omission, the *Dental Hygiene Act*, the *Regulated Health Professions Act, 1991* or the regulations under either of those Acts), paragraph 52 (disgraceful, dishonourable or unprofessional conduct) and paragraph 53 (engaging in conduct unbecoming a dental hygienist) of section 15 of Ontario Regulation 218/94 under the *Dental Hygiene Act, 1991*.

**B. THE DISCIPLINE COMMITTEE ORDERS THE FOLLOWING PENALTY:**

1. Ms. Wehrle is required to appear before a panel of the Discipline Committee immediately following the hearing of this matter to be reprimanded, with the fact of the reprimand and a summary of the reprimand to appear on the public register of the College;
2. The Discipline Committee shall direct the Registrar to revoke Ms. Wehrle's Certificate of Registration effective immediately.
3. Ms. Wehrle is required to pay the College costs in the amount of \$750.00 within six months of the date of the Discipline Committee's order.
