ACKNOWLEDGEMENT AND UNDERTAKING

 - 6. I further acknowledge that if I ever apply for membership, registration, licensure or similar status with the College in the future, the College will be entitled to prosecute me on the original allegations against me as well as for the breach of this undertaking and that the College will be entitled to rely upon this undertaking for that purpose.
 - 7. I acknowledge that once my resignation is tendered, I will not be entitled to use the title "dental hygienist" or any abbreviation thereof or equivalent in another language, I will not be entitled to hold myself out as a person who

is qualified to practise in Ontario as a dental hygienist and I will not be entitled to imply that I am a dental hygienist in Ontario.

- 8. I acknowledge that the College is required to include the fact of my resignation and this undertaking in the College register and it is required to publish the fact of the undertaking on the College website.
- 9. I acknowledge that the College will seek an indefinite adjournment of the discipline hearing against me. I acknowledge that the College will be entitled to reinstate the discipline hearing if I ever breach this undertaking.
- 10. I further understand, acknowledge and agree that:
 - a. I fully understand the terms of this Acknowledgement and Undertaking;
 - b. I am signing this Acknowledgement and Undertaking voluntarily and without compulsion or duress; and
 - c. I have been advised by the College to obtain independent legal advice prior to signing this Acknowledgement and Undertaking and I have either done so or I have had an adequate opportunity to do so.
